THE STUDIO Refers to Stephen Walker, Jr., Vision Videography, Vision Sports, its lessees, contractors or sub-contractors, employees, agents or servants. If any portion of this agreement should be determined to be invalid, it is agreed that the invalidity of such portion shall not affect the validity of the remaining portions of this agreement. By signing, Client certifies that they have read both sides of this contract and agree to the terms and conditions.

AGREEMENT: A firm and binding agreement exists between Studio and Client only after a minimum 50% deposit has been paid, with the remaining balance due and payable upon completion and delivery of the video DVD. The deposit is non-refundable.

DISPLAY RIGHTS: It is understood that the Studio reserves rights to exclusive use of the highlight video and reproduction, and you grant the Studio rights for display use of videos produced under this agreement.

RIGHTS: Client is required to provide all video content to be used in highlight video. Client warrants that he/she has the legal rights to anything the Studio will video including photos, audio, music and any other elements used in Client's video. Client agrees to indemnify and hold the Studio harmless for any loss, damage, or liability for infringement of any rights arising from the use of copyrighted material.

DELIVERY OF VIDEO/DVD-R: Will be in accordance with the delivery option selected in the Project Details section of this agreement. The delivery timeframe begins at the time 50% deposit is received by Studio and all necessary materials have been provided to Studio. The surcharge amount guarantees delivery within the indicated timeframe. The completion period is only an approximate length of time and any longer periods necessary for completion for any reason will not void this contract. Should video be delayed beyond selected timeframe Studio will adjust delivery surcharge to be in congruence with the actual delivery timeframe. The Studio cannot accept responsibility for material lost or damaged in transit.
